This "Personal Data Owner Application Form" (Form) has been prepared to enable the data owner to exercise the following rights under Article 11 of the "Personal Data Protection Law No. 6698" (Law):

- a. To learn whether personal data is being processed, b. To request information if personal data has been processed, c. To learn the purpose of processing personal data and whether it is used in accordance with that purpose, d. To know the third parties to whom personal data is transferred domestically or abroad, e. To request the correction of personal data if it has been processed incompletely or inaccurately and to request that the correction be notified to third parties to whom the personal data has been transferred, f. To request the deletion or destruction of personal data if the reasons for its processing no longer exist, even if it has been processed in accordance with the Law and other relevant laws, g. To request that the actions taken in accordance with subparagraphs (e) and (f) be notified to third parties to whom the personal data has been transferred, h. To object to any result arising against the person through the analysis of processed data exclusively by automated systems, i. To demand compensation for damages in case of suffering a loss due to unlawful processing of personal data.
